#### Reading

 On the Spring 2024 ELA EOG assessment, UES will increase the percentage of students scoring proficient and above by 5 percentile points (18% to 23%) <u>AND</u> decrease the percentage scoring beginning level by 5 percentile points (52% to 47%)

### Goal Area 2: Increase Student Achievement in Math

 On the Spring 2024 Math EOG assessment, UES will increase the percentage of students scoring proficient and above by 5 percentile points (21% to 26%) <u>AND</u> decrease the percentage scoring beginning level by 5 percentile points (40.5% to 35.5%)

### Goal Area 3: Increase Student Achievement in Science

3) On the Spring 2024 Science EOG assessment, UES will increase the percentage of students scoring proficient and above by 5 percentile points (12.5% to 17.5%) <u>AND</u> decrease the percentage scoring beginning level by 5 percentile points (68% to 63%)

#### **Goal Area 4: Improve Student Discipline**

 During the 2023-2024 school year, UES will increase the percentage of students with 0-1 ODRs from 92% to 95%.

# 1) On the Spring 2024 ELA EOG assessment, UES will increase the percentage of students scoring proficient and above by 5 percentile points (18% to 23%) AND decrease the percentage scoring beginning level by 5 percentile points (52% to 47%)

As a school – We will plan and teach lessons that meet the individual reading needs of our students. As a parent – I will help my child attend school daily, on time and prepared to learn. I will also help my child with reading at home each day.

# 2) On the Spring 2024 Math EOG assessment, UES will increase the percentage of students scoring proficient and above by 5 percentile points (21% to 26%) AND decrease the percentage scoring beginning level by 5 percentile points (40.5% to 35.5%)

**As a school** – We will plan and teach lessons that meet the individual math needs of our students. **As a parent** – I will help my child attend school daily, on time and prepared to learn. I will also help my child with math at home each day.

As a student – I will fully participate in my learning by asking questions, participating in class, working cooperatively with others, turning my homework in on time, and reviewing math problems.

# 3) On the Spring 2024 Science EOG assessment, UES will increase the percentage of students scoring proficient and above by 5 percentile points (12.5% to 17.5%) AND decrease the percentage scoring beginning level by 5 percentile points (68% to 63%)

*As a school* – We will plan and teach lessons that meet the individual science instructional needs of our students.

As a parent – I will help my child attend school daily, on time and prepared to learn. I will also help my child with science vocabulary at home each day.

*As a student* – I will fully participate in my learning by asking questions, participating in class, working cooperatively with others, turning my homework in on time, and reviewing science vocabulary.

### 4) At the end of the 2023-2024 school year, 95 % of students will have 0-1 tier 1 office level referrals.

**As a school** – We will use consistent classroom management routines and Positive Behavior Supports and Capturing Kids Heart strategies to maintain an orderly classroom and school environment that is conducive for instruction. We will communicate with parents regarding school rules, behavior expectations, and safety concerns.

**As a parent** – I will respond and communicate with my child's teachers regarding classroom behavior. I will discuss the school's rules and behavioral expectations with my child. I will reinforce good behavior at school and support the classroom discipline plan.

As a student – I will follow the school and classroom rules so that all students can learn and be safe. I will be safe, responsible, and respectful.
